## Privileges of a Villa Gold Membership

The following is an overview of the most commonly asked questions related to the Villa Gold Membership. A Villa Gold Membership is non refundable and is equivalent to Gold Membership at the Snowmass Club (which is no longer sold), plus several important enhancements.

## Villa Gold Monthly Dues

Dues are charged on a monthly basis in accordance with the status of the unit as of the billing date.

Snowmass Club will not pro-rate dues. Current dues level, if in the rental pool:

1-bedroom or Non Rental unit- \$316 | 2-bedroom - \$619 | 3-bedroom - \$928

## General

Villa Gold specifics for the owner:

- Family membership and includes children up to the age of 22.
- Access to all the Athletic Club facilities, locker rooms, pools, and hot tubs.
- Spa and wellness services, personal training, programs, events and on-site childcare.
- Food and Beverage minimum of \$800 per year.
- Member only dining at Sage Restaurant.
- 20% Food and Beverage discount at Black Saddle Bar & Grille.

## **Tennis**

- Advanced court bookings, up to 7 days, anytime of day.
- Complimentary indoor and outdoor courts.
- Services, instruction, events, and programs at member rates.

## **Golf**

- Member rates on greens fees, currently \$35 per round which includes green fee, cart fee and range usage.
- Advanced golf tee times, up to 8 days, anytime of day, including member only play periods.

- Services, instruction, events, and programs at member rates.

## **Rental Program Overview**

The exclusive additional privileges of a Villa Gold membership include:

- The unit owned by the Villa Gold member may be in the rental program under the management company designated by the Club Villa Association Board of Managers as the Villas Preferred Unit Management Provider. Currently this is Destination Resorts.
- Under the above conditions the unit is designated a “Club Access Unit” therefore its Renters have privileges that include access to the Athletic Club at no charge and to Member only dining at Sage Restuarant.
- Renters may book golf tee times 3 days in advance, after 1 p.m. at the guest rate of \$250 per person, per round.
- Access to preferred hotel guest rate, currently 12-1 p.m. Currently \$158.
- Renters may book indoor tennis courts day of play, at the then current guest rate.
- Renters may book outdoor tennis courts day of play, complimentary.
- All other clinics/lessons/services/purchases are charged at the then current public rate.
- A Villa Gold member may remove the unit from the Rental Program and give up the associated privileges for rental guests and reduce the monthly dues payment to one monthly Gold dues regardless of unit size at the then current rate. (Currently \$316 per month.)
- The Villa Gold member retains the right to restore the unit to the Rental Program at a future date in accordance to the HOA and Snowmass Club Termination Agreement, and by returning to the payment of the appropriate dues level for the unit. However, once the unit is taken out of the rental pool it cannot be reinstated as a “Club Access Unit” for one year. The only exception to this one year restriction would be if the Villas Gold member sold the unit within the year and the buyer became a Villas Gold member at the sale. In that case the new owner could restore the unit to the Rental Program at any time after the purchase by payment of the appropriate dues level for the unit.
