Hi Tim – the projects are essentially what is presented on the web page, [<https://www.aspen.gov/1330/Gorsuch-Haus-and-Lift-One-Lodge>]. There have been some very minor changes to both projects that members of the public would likely not notice or be concerned about.

Lift One Lodge is in for building permit review – I would imagine we have issuance in early 2025. Gorsuch/Aman is anticipated to submit for permit in the coming months. I would be surprised if it is not in before the close of 24.

As both projects move through permit review, the City and the two developers – and SkiCo will be working on a project phasing/construction timeline in coordinating the various components of the project. There is potential that we could start to see some initial physical work on the L1L site in summer of 2025, but that is not official or confirmed in any way.
