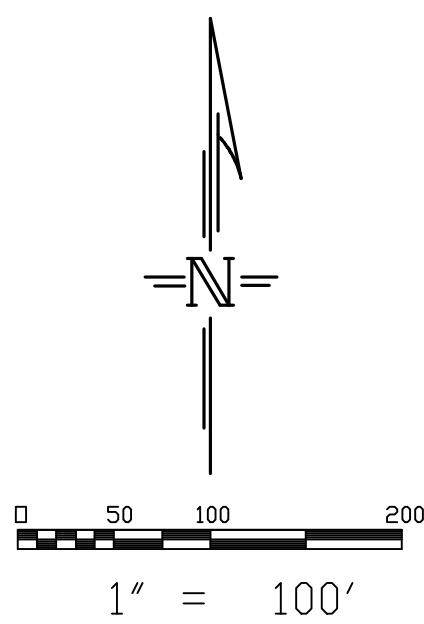


IMPROVEMENT SURVEY PLAT

1) LEGAL DESCRIPTION:
A TRACT OF LAND IN LOTS 9 AND 15, SECTION 27, TOWNSHIP 9 SOUTH, RANGE 85 WEST OF THE 6TH PRINCIPAL MERIDIAN DESCRIBED AS FOLLOWS:
BEGINNING AT A POINT ON THE WESTERLY LINE OF COUNTY ROAD WHENCE THE EAST ONE-QUARTER CORNER OF SAID SECTION 27 BEARS NORTH 89 DEGREES 39 MINUTES 20 SECONDS EAST, 1,730.93 FEET; THENCE NORTH 17 DEGREES 37 MINUTES WEST, 69.30 FEET ALONG THE WESTERLY LINE OF COUNTY ROAD; THENCE NORTH 18 DEGREES 31 MINUTES WEST, 530.70 FEET ALONG THE WESTERLY LINE OF COUNTY ROAD TO THE NORTH LINE OF SAID LOT 9; THENCE SOUTH 89 DEGREES 46 MINUTES WEST, 480.41 FEET ALONG THE NORTH LINE OF SAID LOT 9 TO THE NORTHWEST CORNER OF SAID LOT 9; THENCE SOUTH 780.05 FEET ALONG THE WESTERLY LINE OF LOTS 9 AND 15; THENCE NORTH 72 DEGREES 23 MINUTES EAST, 702.89 FEET TO THE POINT OF BEGINNING, ACCORDING TO THE PLAT OF WEINGLASS/MOORE LOT LINE ADJUSTMENT RECORDED MAY 8, 2021 AS RECEPTION NO. 588848, COUNTY OF PITKIN, STATE OF COLORADO.

A BEARING OF S18°31'00"W BETWEEN A FOUND #5 REBAR NO CAP AT THE N.E. PROPERTY CORNER OF PARCEL 1 AND A FOUND #5 REBAR AND 1 1/4" ALC BLANK AT THE EASTERLY PROPERTY CORNER OF PARCEL 1. BEARINGS BASED ON THE EAST LINE OF PARCEL 1 ACCORDING TO THE PLAT OF WEINGLASS/MOORE LOT LINE ADJUSTMENT RECORDED MAY 8, 2021 AS RECEPTION NO. 588848

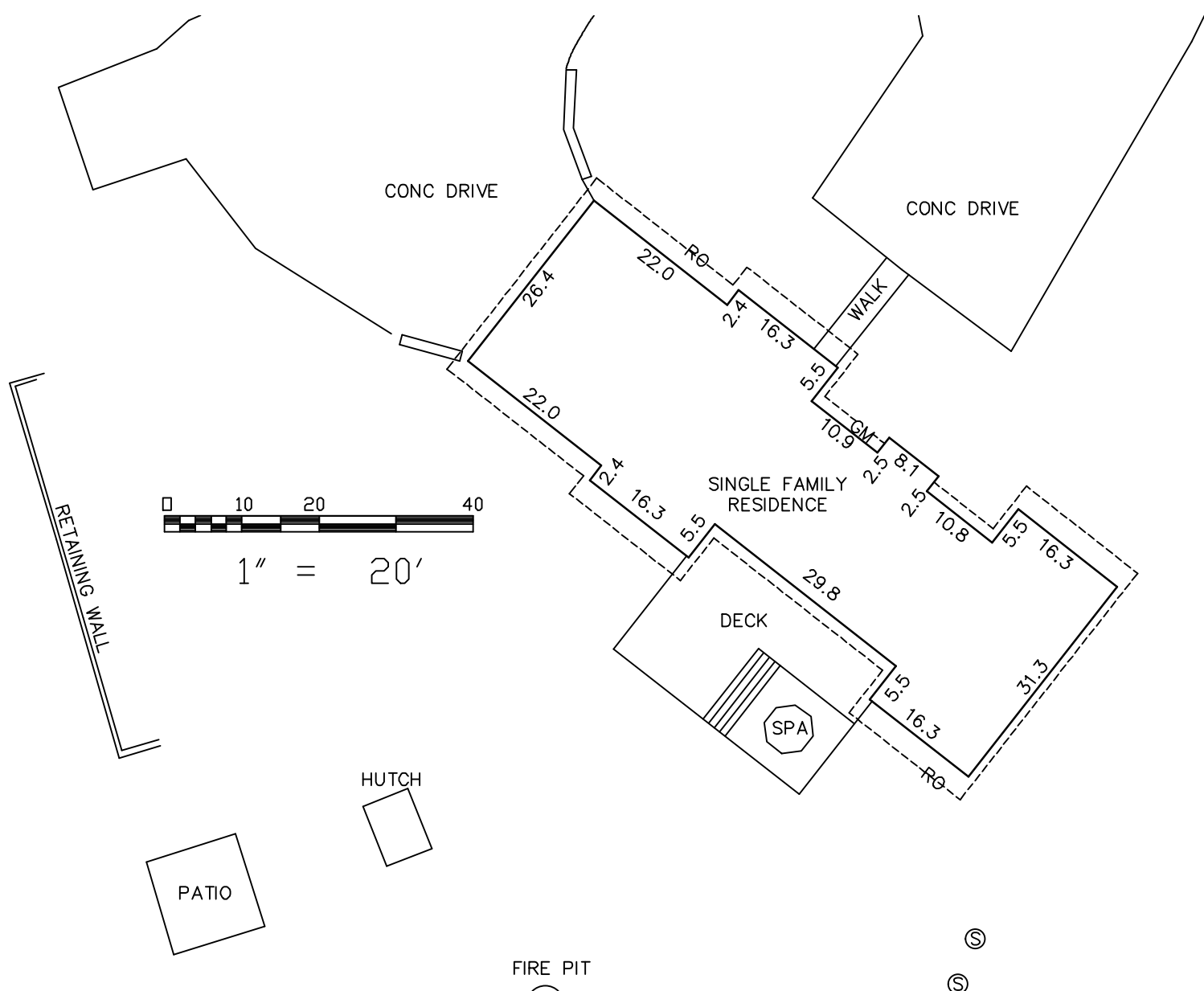

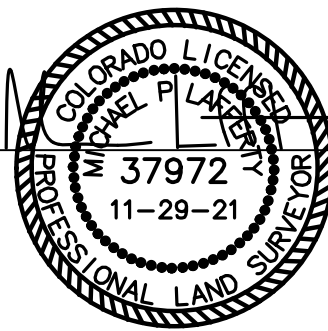
